TENDER NO. AE/028/2007-08/HQ/G/38 FOR THE SUPPLY, INSTALLATION AND COMMISSIONING OF AIR NAVIGATION EQUIPMENT (DVOR/DME FOR MWANZA AND VOICE RECORDER FOR JNIA) FOR THE TANZANIA CIVIL AVIATION AUTHORITY

1. This Invitation for Tenders follows the General Procurement Notice (GPN) which appeared in the local news papers namely, Daily News, Guardian, Mtanzania, Zanzibar Leo and Habari Leo all dated 17th August 2007.
2. The Tanzania Civil Aviation Authority (TCAA) has set aside funds out of its financial budget for the financial year 2007/2008 for the procurement of various goods, works & services. The Authority intends to apply part of the funds to cover eligible payments due under the contract (s) for which this invitation for tenders is issued.
3. TCAA now invites sealed tenders from eligible tenderers for the supply, installation and commissioning of Air Navigation Equipment as follows:

Tenderers may tender for a SINGLE LOT or ALL TWO LOTS, but in each case tenderers must quote for ALL ITEMS AND QUANTITIES in each lot. PARTIAL TENDERS WILL NOT BE ACCEPTED.

4. Tendering will be conducted through the International Competitive Tendering procedures specified in the Public Procurement (Goods, Works, Non-Consultant Services and Disposal of Public Assets by Tender) Regulations, 2005.
5. Interested eligible tenderers may obtain further information from, and inspect the Tendering Documents at the office of the Secretary TCAA - Tender Board, Tanzania Civil Aviation Authority, IPS Building, 5th Floor, Room No. 514, Azikiwe/Samora Avenue P.O. Box 2819 Dar es Salaam from 7:30hrs to 15.30hrs local time, Mondays to Fridays inclusive, except on Public Holidays.
6. A complete set of the Tendering Documents may be purchased by any interested eligible tenderer on submission of a written application to the address given in paragraph 5 above and upon payment of a non-refundable fee of Tshs. 100,000/= or its equivalent amount in a freely convertible currency. The method should be by cash or banker's cheque payable to the Director General, Tanzania Civil Aviation Authority, P. O. Box 2819, Dar es Salaam.
7. All tenders in one (1) original plus three (3) copies properly filled in and enclosed in plain sealed envelopes must be accompanied by an original Tender Security in an acceptable form in the amount of Two and a Half Percent (2.5%) of the Tender amount.

Tender Securities must bear the name and address of the Director General, TCAA, P.O. Box 2819, Dar es Salaam.

8. Tenders must be delivered either by hand or be sent by registered post so as to reach the Secretary, TCAA - Tender Board, IPS Building- 2nd Floor, Room 215, Azikiwe Street /Samora Avenue, P.O. Box 2819, Dar es Salaam before the deadline for submission of tenders.
9. The Deadline for submission of Tenders is 11:30 hours local time on Wednesday 9th April 2008. Tenders will be opened in public and in the presence of tenderers' representatives who choose to attend in the Tanzania Civil Aviation Authority's Conference Room, IPS Building-5th Floor, Dar es Salaam. Tenders sent by post must be registered. The outer cover shall be clearly marked **"TENDER No. AE/028/2007-08/HQ/G/38 FOR THE SUPPLY OF AIR NAVIGATION EQUIPMENT (DVOR/DME FOR MWANZA AND VOICE RECORDER FOR JNIA) FOR THE TANZANIA CIVIL AVIATION AUTHORITY, NOT TO BE OPENED BEFORE 11:30 HRS LOCAL TIME ON WEDNESDAY 9TH APRIL 2008."**

10. Combined pre-tender site visits and meetings will be conducted on 11th March 2008 at 11:00 hrs local time and on 12th March 2008 at 11:00 hrs local time, in Mwanza and Dar es Salaam respectively.
11. Tenders not received, not opened and not read out in Public at the Tender Opening Ceremony shall not be considered for evaluation irrespective of the circumstances. **TELEGRAPHIC, E-MAIL AND LATE NON-TELEGRAPHIC, TELEFAX, E- MAIL OR PORTION OF ANY TENDER SHALL NOT BE ACCEPTED.**
